

## Exploring Lifespan Development Chapter 4

This book aims to provide students with an understanding of important theoretical perspectives and specific models of adaptation to loss. It is assumed that loss and change are normal processes which occur within a social and cultural context, and the reader is introduced to historical and cultural perspectives which illustrate the diversity of approaches to loss. Based on the First Biannual Lifespan Development Conference, this volume offers a multidisciplinary and multidimensional approach to the study of lifespan development in the areas of neuropsychology, cognition, behavior genetics, and perception. The objective of the conference was to provide a lively forum for the discussion of issues related to lifespan development and to reflect on important topics challenging the field during the 1990s. The chapters in this book, motivated by the conference presentations, cover: \* the assessment and evaluation of developmental changes in visual perception; \* the contribution of behavioral genetic factors to development; \* the predictability of perinatal risk factors as they relate to cognitive and linguistic outcomes; \* the neuropsychological changes during aging; and \* innovative approaches to the study of cognitive development using neuropsychological testing methods. In the past fifty years, scholars of human development have been moving from studying change in humans within sharply defined periods, to seeing many more of these phenomenon as more profitably studied over time and in relation to other processes. Life-Span Developmental Psychology: Normative Life Crises is a compilation of papers that deals with various points of view between the academic perspective — studies in developmental psychology and applied perspective — and the practical efforts of social workers to help individual clients. Part I discusses normative life crises from the two perspectives that include human behavior theory in social work education. Part IV deals with the normative life crises and the social system, including socialization, life course, changing work cycles, and public policy on death. There is currently considerable focus on psychosocial issues for persons with aphasia and their significant others. The nature and extent of impact varies, as seen in the book's in-depth examination of narrative self for persons living with aphasia, ALS, Parkinson's disease, and dementia, as well as those aging without impairment. The authors present theoretical grounding for using the concepts of self and the idea of a social and cultural tool kit that enables clients to interact with others and to define themselves in the context of those around them. The text moves from theory to qualitative analyses of living with neurogenic disorders to implications for clinical interventions for individual clients and their significant others.
